**Glossary of terms**

Actual	Non-Coincident Peak or actual demand for the billing cycle
Ratchet	80% of the highest demand in the past 11 months
Actual or Ratchet	Billing demand will be the higher of the NCP or 80% of the highest demand in the past 11 months
4CP (Coincident Peak) - applies to ASM only	Average of June, July, August, and September coincident peak demands at the time of ERCOT system peak of previous year
Actual or 4CP	For NIDR/AMS meters, billing demand is NCP - for IDR meters, billing demand is 4CP
